About Sanctuary Supported Living

At Sanctuary Supported Living we provide supported housing, move-on accommodation, CQC registered services and floating support to help people across England on their pathways for independence.

We specialise in services for young people, homeless families and individuals, people with physical disabilities, learning disabilities and people with mental health needs.



Accommodation



Accommodation type

20 unfurnished apartments on three floors, each with a bedroom, living room, accessible kitchen and en-suite wet room or bathroom. There is level access throughout and a lift to all floors.



Location

Near the centre of Lowestoft, close to shops, cafés, Lowestoft library, public transport links and the seafront.



Communal areas

A lounge, dining area, laundry room and garden.



Technology

Integrated emergency pull cord alarm system and ceiling hoist track system throughout. All apartments have the option to fit additional assistive technology. Personal pendant alarms are also available and there is Wi-Fi throughout the property.



Safety and security

Staff office on-site, CCTV and a secure door access system help to ensure residents' safety and security.



Rental agreement type

All apartments are let on an assured shorthold tenancy agreement.

Care and Support

Everyone is supported to achieve greater independence. Our highly-trained staff are on-site 24 hours a day, seven days a week, giving residents peace of mind that support is always on-hand.

We can provide 24-hour care and support, including personal care, depending on individual needs. Residents can purchase additional telecare technology to further promote their independence.

Tailored care, support and assistance includes:

- › Daily living skills
- › Maintaining a tenancy
- › Maintaining health, safety and security
- › Managing finances (budgeting and benefits)
- › Cooking, cleaning and shopping
- › Positive behaviour management
- › Managing personal care and medication

All care and support needs will be assessed before an application is accepted.

- › Be aged 18 or over
- › Have a physical disability
